


Visma.net AutoPay and ISO 20022






What is Visma.net AutoPay?

Visma.net AutoPay is a fully automated cloud service designed to handle bank statements. This service includes outgoing payments, status updates, incoming payments, statements from the bank and direct debit for some of the countries. Visma.net AutoPay will provide integration with all major banks in Finland, Sweden, Norway, Denmark and the Netherlands.

Both European and National Bank Authorities are implementing standards for bank payments within the next few years. This will influence all Visma ERP customers who are conducting foreign payments. The new standard is enforced by EU is ISO 20022. The Swedish bankers association states that only payments in Euro must use the ISO 20022 format from November 1st, 2016. All other payments can use the legacy formats until the end of 2017. From 2018 all payments must be ISO 20022 compliant. Historically, there are several different ways to execute bank payments from Visma ERP solutions. Going forward, Visma will only support ISO 200022 through Visma.net AutoPay. There are currently two versions of AutoPay in Visma:

- 1. Visma AutoPay 3: Only supported by Visma Business and only for Norwegian Banks.
- 2. Visma.net AutoPay 4: Supported in all markets and for most of Visma ERPs Visma.

Visma.net AutoPay 3 will not provide support for ISO 200022.
